



Launch and Recovery Syndicate

The second compulsory work party for the Syndicate's members is scheduled for Sunday 6th September, starting at 09.00am prompt. Members are reminded to bring, if possible, some of the following: chipping hammers, wire brushes, files, paint brushes, grease guns, saws, claw-hammers and miscellaneous spanners. The Club will as usual, supply Zinc primate paint and grease.

There have been a couple of incidents this year resulting in major damage to two different chain-lifting blocks. This damage was entirely due to incorrect usage. The first instance took place on the 27th March, and the second on the 25th April. Both incidents were entirely avoidable if well-established procedures had been followed.

In the first instance, the hand-hauling chain was being pulled across the chain-plate: this resulted in jamming of the chain-plate retaining bar rollers, leading to fracture of the retaining bar, thus taking that chain block pout of action. Needless to say, craft can only be lifted/lowered with <u>four</u> serviceable chain blocks.

In the second incident, after the lifting of a craft, a chain-block hauling-chain was not securely stowed on the mobile hoist, resulting in massive damage to another chain-plate when the grounded hauling-chain was trapped beneath one of the mobile hoist's wheels.

All members of the Syndicate must be aware of the operating procedures that have evolved over many years of safe usage, and must act responsibly.



On a few occasions this year, some members arrived well after the stated start-time. This will no longer be tolerated. On the day, or days, of either launch or recovery, members must appear no later than the stated start time. Members who are not, will neither be launched, nor recovered, during that session.

As I write this report, the cruiser sailing season is nearly half-gone, if you're pessimistic, or half-left, if you're optimistic! However, whatever your outlook, it would be appropriate to check your mooring chains and shackles at the next available spring tide. Whilst you are, why not be neighbourly and have a look at your immediate neighbour's mooring chains etc. You may recall that I have previously mentioned that there are some very poor quality chains and shackles on the market that wear very quickly!

Finally, whatever your inclinations, whether cruising or racing or both, Happy Sailing!

Matters arising from the minutes there were no matters arising.

Commodore's Report

It is with great sadness that I have to inform the meeting that Sylvia Abel passed away last month. Sylvia had been a strong supporter of the club and held the post of Honorary Treasurer for twenty-nine years. She will be sadly missed. The club was well represented at her funeral and a donation has been sent to "Fairhavens Hospice at Home" as requested by Graham.

As last year it is my intention to give a short report as it has been my policy to keep members informed throughout the year. I do not generally intend to talk about Sailing or House matters. The respective rear commodores will talk about their own areas. That means I can pass the blame for the poor weather to Penny!

Last year I referred to this leaving me with no duties – but again I do appear to have been very busy - Luckily I have been very well supported by a great team!

I refer now to a few of the major events.



The biggest thing was the construction of the conservatory and although local contractors carried this out I did feel that I needed to be here every day. Once the conservatory was completed we were left with a number of associated jobs.

My thanks to Keith and John for laying the tiles but I am not sure my car has recovered from bringing all 35 sq. metres, and cement to the club in one go!

I must also thank Craig and his team for the swift construction of the decking and the loan of the cement mixer. The mixer came in for some heavy use when I made the steps to the west side door, steps to the bottom of decking and then lifted and re-laid every slab in of what remains of the old patio. I must thank Julia who moved every slab at least three times.

I am not sure that many of you know that there is a fee for permission to have a slipway. The Anchor owners have paid this for the last 42 years. However, the lease came up for renewal this summer and Punch Taverns decided that they did not need this additional expense. In the light of this the Crouch Harbour Authority asked us if we would care to take over the lease at £1250 pa. I spent some time talking with Punch Taverns and managed to convince them that it would be far too expensive to draw up a new lease with us and they decided to renew the lease for the slipway and bear the additional cost themselves.

One of the other major tasks has been to clear the club grounds. With the support of the executive and some drastic action including cutting up one boat we reached a low of just three cruisers in the yard by the end of the summer. Just it time as we have had a large influx of new boats this year for winter storage.

This year has also been a continuation of the programme to reduce cost in all areas. Careful pruning of expenses has minimised the effect of the huge rises in many of the charges made on the club. I had hoped that I would have been able to announce



proposed new fees this year a little less than the 10% that I warned of at the last AGM However, the huge increases in energy prices this year and the 72% increase in the rates charge has meant that we are looking towards increases of nearly 10%. I do not want to make promises for the new commodore but with energy prices stabilising and the possibility of better rate discount next year I would hope that we are looking at a smaller increase next year.

I would like to take this opportunity to thank everyone for the support that I have received this year and say that I have enjoyed both the little sailing that I have managed and the social events but I leave the details to our rear commodores.

Hon. Treasurer's Report

(Copies of the Income/Expenditure account were circulated)

This is the second year of only having an income & expenditure report; therefore, it is easy to compare the two years.

I will quickly run through the movement in the accounts.

Income

Subscriptions are up slightly due to the increase in the annual subscription. I have shown the boat registration separately as I was requested to do at last year's AGM.

The bar shows down from last year but this is reached purely by deducting expenditure from income and meeting the cost of the Bar Steward. However, when taking into account stock brought forward and carried forward the profit margin on the Bar is 46%, which is better than last year.

The kitchen obviously did very well this year.

Interest is up very slightly.

Social events show a large profit this is mainly from Dinner-dance Christmas party, quiz night and the fitting out supper. Prices have been adjusted on the dinner-dance and there is very little profit this year.

Regatta balance is down slightly but it was an exceptionally successful day and donations totalling £500 were made to RNLI, Heartwatch, Strokebusters and Rochford Tractor Club.

Various donations were received including £8000 towards the conservatory.

Race fees are up only because some fees for Sept 07 were not banked until Oct and,



therefore, are in this year's figures.

Sundry is partly for non-attendance at work parties plus the sale of a dinghy.

Regalia products were sold this year and no additional stock purchased.

Expenditure

Rent etc. is up as last year was not a full year at the new rent for the field, also council tax has increased as we haven't been given such a large discount as previously.

Heating and lighting is down, which is a surprise. We believe we are feeling the benefit of the new double-glazed doors and windows.

Trade refuse. There was a concern at the increase in cost and collections have now been reduced, also RCH is considering other contractors.

Insurance, cleaning, telephone, printing and maintenance of clubhouse are all very little change from last year.

Maintenance of equipment is up, as extra work was needed on the rescue boats.

Fuel increase is as expected.

Trophies and awards up slightly and only one donations was made this year

Commodore's fund is up, no specific reason, other than more guests at dinnerdance.

Sundry substantially down on last year and includes bar licence, music licence and web page.

Profit/Loss



This all shows a loss on the year of just over £10,500 but as we spent £14,000 on the conservatory and £1600 on decking and electric's I feel the year end balance is acceptable.

I don't feel there is anything more I can add unless there are any questions.

Rule changes

The Executive Committee proposed 1 rule change as follows:

In order to prevent any repetition of the problems encountered when the new owner of "Per Mare" left his craft on our premises for many months without either joining the club or offering any reasonable storage fee The Executive Committee proposes



that the following be incorporated into our rules as a new clause in the section headed 11 boat park on page 12 of the rule book.

Craft belonging to non-members

The seller's responsibility

Any member selling a craft must notify an officer of the club of the proposed sale and details of the new owner

The seller must not make any undertaking committing the club to any course of action.

An officer or officers of the club will meet with the purchaser to assist as required

The new owner wishing to join the club

If the new owner wishes to join the club an application can be made, a joining fee and annual subscription paid, with launch/recovery fee (if appropriate).

If the application is unsuccessful then the matter will be treated as for a new owner not wishing to join the club.

The new owner not wishing to join the club

If the purchaser does not wish to join the club or has had an application refused the craft must be removed from the club within 1 month of the purchase date. The club will assist with launching if required. Craft that remain in the club after one month will incur a charge of £50 a month (or part month) and legal steps will be taken to remove the craft

Lapsed membership

Any member who allows their membership to lapse and leaves their craft in the



club will be treated as "Owners who do not wish to join the club."

Discussion & Resolution on the proposed rule change

There was a fairly wide ranging discussion and it was pointed out that, as it stood, the rule would cover craft outside the club premises.

The secretary then proposed that the heading be altered to read

"Craft on the club premises not belonging to club members"

This proposal was seconded and carried without dissent.

The original proposal, as amended was then approved without dissent.

Election of House Committee

Pat Harris, Penny Yarwood, Alex Gore, Jim McAvoy, Adrian Reynolds, Ron Pankhurst and Pat Robins have agreed to continue in service. Liz Hutchinson volunteered to join the committee. All were approved unanimously. It was proposed and agreed by the meeting that "If a suitable person can be found, the Executive Committee be empowered to appoint that person as Rear Commodore House until the next AGM."

Sailing Committee

It was noted that the rules do not require the AGM to elect the sailing committee which used to consist of the various class captains. However Penny Harris wished to advise the meeting of the membership. The committee is made up as follows Penny Harris (RCS), Tim & Amanda Harris, Ben Harris, Adrian Reynolds, Matt Pickett, Luke Layzell & Michael Ettershank.

At this point the Commodore formally closed the AGM but stated that any points which members wished could now be raised under "Any other business"

Ten Year Plan

It was noted that all but one of the items on the current plan have been completed. The exception is the refurbishment of the kitchen, which was recently inspected and passed by the Local authority. Future rules may require change and it is thought



inappropriate to spend money at present.

Suggestions for inclusion in the forward plan were invited and made as follows

- (1) Consider a comprehensive review of security
- (2) Consider supply of power to the outbuildings and the top field.
- (3) Consider surfacing the car-park and marking parking bays.
- (4) Consider hardening access to and in the top field
- (5) Keep the state of the roof under review and take remedial action as necessary
- (6) Consider the possibility of the provision of a roof terrace
- (7) Consider extending clubroom to include the current office space
- (8) Consider replacement of the flagpole
- (9) The work to move the tender park is now scheduled for early 2009. There was some concern expressed that the move of tenders might undermine security. A security chain is to be provided so that tenders may be padlocked to it.
- (10) Consider using Yale keys so doors lock automatically on closure.

These recommendations will all be considered by the Executive Committee with a view to inclusion in the plan

Summer Lay-up Fees

John Cowling read a letter from a member who proposed a reduction in the escalating fee for boats that are subject to lay up fees. The suggestion was that a cap of £100 be put in place for boats for sale (Being offered outside the club) and a cap of £200 for those not for sale. This was discussed for some time. It was noted



that as notice had not been given by the deadline the AGM could not change the position at this time. It was pointed out that, if members feel strongly about this and can get the relevant support an EGM could be called to settle the matter.

It was suggested that, to test the feeling of the meeting a show of hands be invited. This was agreed.

All present, with the exception of 2 against and 10 abstentions voted in favour of the status quo.

Use of conservatory

Commodore was asked to explain why action had not been taken, as requested by 20 members to allow access to the conservatory when the clubroom is not open.

Commodore explained that some of the 20 members some had disassociated themselves from the "petition".

He explained that members had failed time and time again to secure the premises and there were real fears that this failure would apply to the conservatory as well.

The Executive Committee had discussed the request at length but it was felt that the request could not be met.

It was also pointed out that a rule change would be required to allow access to such parts of the club without a key holder being present.
